

What are the Wage & Tax Reports called in the different states?

Most carriers in most states ask that a wage and tax report be submitted with the group paperwork to help identify the eligible employees within the group. The wage & tax report is a quarterly report that employers in most states must file with the state's workforce commission so that required unemployment taxes may be calculated. These reports are known by different names in different states. On this page, we will provide the names of the reports for the different states so you can clearly communicate to employers what form you need. Unfortunately, it's not always clear what the report is called – in some states, the report is referred to by different names. Some states have a form number for the report; others do not. In the event that the report is not listed for your client's state or the employer does not know the report by the name listed, you might describe it to them as the quarterly report that they file with the state's workforce commission that lists each W-2 employee along with their income for each month of the quarter. You might also find the form's name in the carrier's underwriting guide.
